Directions relating to Timetabling Dispute TTP 1172:

Thank you for your letter, dated 14th November 2017, regarding Directions relating to this dispute. In answer to the first two points, for GB Railfreight, please note the following information:

- 1) Very initial consultation on the proposed new train path has occurred by telephone and, therefore, unfortunately is not available in writing. However, Page A shows details of an e-mail between Julie Garn (GBRf Business Manager, Intermodal) and Hutchison Ports stating that GBRf has identified paths on the Felixstowe branch and is kick-starting the process for the tendering of a new slot at the dock. This can only occur once train paths have been identified and confirmed.
- 2) For a previous, 33rd slot at Felixstowe, Page B gives an example where GBRf has stated to Hutchison Ports that it has found robust capacity on the Network, which was then confirmed by Network Rail as being true. This confirmation is shown in GBRf's Sole Reference Document Appendix E (Page 33).

On page C of this document, correspondence from Martin Woor (Hutchison Ports), on 9th May 2016, states that "With reference to GBRf's proposal in respect of the 33rd train slot from Felixstowe, I would ask if you could obtain confirmation of path ownership/ validity from Network Rail". This, clearly, is requesting confirmation, first, before any further action on the port slot, to GBRf or other freight operating companies, takes place.

On page D of this document, correspondence from Martin Woor (Hutchison Ports), on 1st July 2015, regarding the 31st slot, states that "*Specifically, but not limited to, we would request that you obtain written confirmation from Network Rail of ownership of track access rights for the proposed rail service and firm up your plans in respect of pre-nomination of import containers prior to vessel discharge"*. This, also clearly implies that for pre-nomination for all slots at the port, Working Timetable Paths, and with them at least Spot Bid Freight Rights, are needed before any port slots are awarded.

In support of my Sole Reference Document, this does beg the question why it is acceptable or right for Network Rail's engagement with the 34th slot to be so different to that with the 33rd and 31st slot which GBRf was successful in winning. There has been no change, as far as the port or GBRf are concerned and it was, clearly, acceptable to Network Rail for these and previously awarded slots at Felixstowe otherwise those train paths would not have been offered.

Please let me know if you require any further information.






